Meeting called to order at 7:33pm by Neville Henderson via conference call.

- Approval of Meeting Minutes Warren made a motion to accept December 10th Board of Directors meeting minutes seconded by Dominic. All in favor. Minutes were accepted.
 All in favour, minutes accepted.
- 2. Business arising from minutes.
 - 2.1 New & Youth Shooter Program With the off season, any other new shooter events are on hiatus, with a couple of clubs sharing dates for events in the spring (example Crumlin has a series of new shooter nights). Emily had a number of requests for shoot clinics and/or coaching by email, and she has responded but not with any specific names, dates, or places yet.

The CUSF continues to recruit new university/college teams with 7 up and running or in the works in Ontario alone. Each team has the opportunity to train and compete in a variety of shooting disciplines, including trap and skeet. Local teams will be looking for clubs and coaching help. This initiative offers a great way to introduce new shooters to the sport. Emily has asked Dave, who heads this group, to provide her with some information/brochures to have on hand for our Sportsmen's Show booth.

The University of Guelph through Ana Tsementzis has an event schedule for March at Hamilton Gun Club. Warren stated that the Hamilton Gun Club will supply all the targets. Pam stated that she has agreed on behalf of the OPTA to supply each of the new shooters with OPTA annual memberships at no charge.

2.2 – Website/Facebook/Twitter – Since the last meeting, Emily has uploaded 26 buy/sell ads, taken 18 down and edited 2 ads. There are currently 54 posts on the buy and sell page. Those who list ads have reported good and rapid results for ads on the website. As an example, she posted an ad yesterday, then posted on Facebook that there were a few new ads on the site, and today that ad came down as the gun had sold.

Since February report the number of members of the OPTA Facebook group page has risen from 619 to 633, up 14 new members. There are 3 requests to join waiting until they respond to her screening message.

2.3 – Ontario Council of Shooters – The Sport Matters Ontario scheduled for January 31, at the ONN office has been postponed with no new date given as yet.

- 2.4 Long Term Strategic Plan Neville would like to meet one more time to finish the main parts of this document. Pam will send out a scheduler to the Board to indicate availability.
- 2.5 100th Provincial Championship Dominic has been researching how to obtain a Lottery licence for a raffle. There are a few documents that are needed such as a financial report, list of Directors and the Constitution and Bylaws. Pam and Dominic will work together to gather the required documents.

A discussion amongst the Board in regards to how the winning ticket would be determined. Paulo will bring suggested ideas to the next Board meeting for further discussion.

All agreed that we should have more than just the gun for raffle. Each Board member is to bring further ideas to the next meeting.

Ideas were brought forward regarding having added prizes for the championship days such as special draw added to Lewis type option ie shells, shooting glasses etc.

Dominic had sent out an email with the proposed hat. Currently the hat was shown in black. Board members asked if perhaps the hat could be in 2 colors, black at the front and a different color on the back. Dominic will look into this suggestion and report back at the next meeting. We would need at least 250 hats if we are giving them out to each person that registers to shoot the Provincial Championships.

Bert has agreed to contact tent rental companies to get quotes.

- 2.6 All Star Team Pam sent out to the Board the list of Ontario All Star teams. It was asked as to why the Men's team only had 3 shooters. Pam stated that it was due to the fact that many shooters either did not have enough Ontario targets or did not shoot the Provincial Championship days. All Board members approved of the list. Pam then asked Emily to post on the website and Facebook.
- 2.7 Toronto Sportsmen Show The Toronto Sportsmen's held at the Toronto International Centre, from Mar 13-17, 2019 has been booked (including booth fee, and electricity paid). A request for volunteers has been posted, and there have been a few times booked so far. Again, Emily would like some information in advance of the show, about clubs who are taking new members and those who are willing to host a new shooter event on a specific date in the spring so that booth volunteers can direct interested booth visitors. Emily tried to access this last year, with limited success.

3. Financial Report

3.1 – Monthly Review – All approved monthly financials.

Pam stated that the first installment of the grant money \$9,945.60 has come in. There is still the last matured GIC money in the chequing account but Pam stated she would like to leave it until after the Provincial Championships to ensure we have the extra money on hand. All Board members agreed.

4. New Business

4.1 Emily received an invitation to a meeting at Toronto City Hall, with a group of people who have decided that there is more strength together than apart. In that group were two former gang

members, three mothers who have lost children to gun violence, one member of a community who started a group to address gun violence in his community, a spokesperson from the firearm and ammunition industry and three from the Canadian Coalition for Firearm Rights, representing hunters and sport shooters. The discussion was incredibly informative and moved this collaboration forward to a place where working together to demand the governments work on the real issue of guns and gangs, is now a reality. Action items from this meeting include a letter, signed by each of these groups asking for a response from the government on the request to develop more effective crime prevention policies, a parliamentary press conference with all at this meeting in Ottawa in the spring, and a commitment from the group to continue to respect the places each come from, and to work together for a common goal of safer communities.

- 4.2 The CCFR, has just launched the 'Canada Down Range' show which offers a much needed series on sport shooting, as there are many on hunting but the sport shooter demographic is largely ignored. The shows, hosted by Rod Giltaca, have been very well received and offer information about current laws, as well as on sport shooting ranges and opportunities for sport shooting across the country.
- 4.3 Canadian Doctors for Protection from Guns, is a group of doctors who have created this group in order to support Bill C71 and proposed gun bans, based on their experience in the emergency room with individuals with gunshot wounds due to a criminal encounter, suicides and accidental shootings involving children. There are, of course, counter discussions from gun owners and their lobby organizations calling this group on their lack of evidence around their claims. The doctor who heads this group was on a radio talk show with Evan Solomon last night, and the proceedings can be heard here.

It is hoped that this initiative will continue to grow, with more teams from other institutions and with students continuing to participate year over year, and hopefully taking up a shooting sport for life.

2.2 – Website/Facebook/Twitter – Since the last meeting, Emily has uploaded 11 buy/sell ads, taken 3 down and edited 2 ads. There are currently 60 posts on the buy and sell page. Aside from trap guns, there are also ads for skeet and sporting clays guns, gun parts, rifle equipment, and reloading equipment.

The website is up to date with respect to shoot schedules, board members, ATA delegate reports, financial statements and AGM minutes. The President's message is over 3 years old. An updated one is requested.

Since the last report the number of members of the OPTA Facebook group page has risen from 633 to 641, up 8 new members. There is 1 request to join waiting until they respond to Emily's screening message.

- 2.3 Ontario Council of Shooters Things have been pretty quiet, with only a few approvals for applications for additional grant money for exceptional events. Darlene from St Thomas reached out to Emily as the Ministry grant required a letter of reference from the OCS, and they had given a two-day extension to get this letter to them. Emily sent an urgent email to the other OCS members who responded quickly and in time to get the application back to the Ministry.
- 2.4 Long Term Strategic Plan Meeting is scheduled for March 30, 2019 at 10am at Galt Sportsman Club
- $2.5-100^{\rm th}$ Provincial Championship Bert sent the Board the information on the tent rental. The company, Classic Party Rental, is in Stoney Creek so close proximity of Hamilton Gun Club. Dominic and

Warren met with the representative and thought the east side close to the Artemis club would work well as we could get power from the club if needed. Paulo stated he would have his generator there as well.

Tables and chairs would cost approximately \$500.00/day.

Paulo talked about a possible caterer he could contract. He will contact them and bring further information to the meeting on March 30th.

Pam stated the majority of the program is done but still waiting for advertisers and sponsors to add. Pam will send what there is so far to Bert and Emily for review and to check for any further edits.

Paulo suggested we have another significant prize for our raffle. He suggested an ATV if we could get one at a discount from Peter Tarnowski. He will contact Peter and bring more information to the meeting on March 30th.

Pam stated she thought Dominic was looking into the lottery license so we will wait until he returns before going any further with it.

There was a discussion regarding silent auction items and possible random draws during championship events. All Board members are to look into finding donations for these two items.

Warren stated the Hamilton Gun Club is working on the kitchen on the west side and should have it renovated and in service for the Championships.

2.6 – Toronto Sportsmen Show – The Sportsmen's Show was another great success this year. Emily had more difficulty in getting volunteers this year, but in the end some volunteers stepped up to take on a second shift, and the booth was fully manned throughout the whole show. Emily has sent a thank you to all the volunteers who spent time in the OPTA booth. While quantifying the success can be difficult, early reports suggest that many are looking for clubs to join and are looking for opportunities to be mentored in the sport, including trap chairs reporting that several people who visited the booth have already joined their clubs or called to make plans to come out to the club. Emily has also responded to a number of emails to the OPTA email address looking for more information, and called a number of people back who had left their contact information at the booth.

Bill stated that a lighter gun is still needed for the simulation program as some had difficulty hold the gun up to the screen. Paulo stated he has a gun that he will donate.

One of the volunteers, Doug Kurt, suggest we put stickers on the OPTA brochures or business cards that we give out saying that if they take the brochure to any club in the province, they will get one free round of trap. Clubs would turn them in to the OPTA for reimbursement if they wanted to. This would help to track whether attendance and interest at the sportsmen show translates into people coming out to our clubs.

There are 13 requests to join waiting until they respond to Emily's screening message. Emily has automated the process of asking the screening question which makes it a bit more efficient.

2.3 – Ontario Council of Shooters – The next Annual General Meeting is scheduled for May 11th 1:00pm at the Toronto International Trap & Skeet Club. Emily is unsure if she will be able to attend but will let the Board know in advance if unable.

- 14. Business arising from minutes.
 - 2.1 New & Youth Shooter Program Emily continues to support the Canadian University Shooting Federation (CUSF) wherever needed. http://www.cusf.ca/

This month, the president was looking for contacts in the Ottawa, Kingston and London areas, so after reaching out to some OPTA members to gauge their interest, Emily connected him with Cesare Forte, Lisa Smith, Ron McGrogan, Ron Rowe and Todd Millard. This will help move post-secondary teams forward with their mandates in these regions.

2.2 – Website/Facebook/Twitter – Since the last meeting, Emily has uploaded 9 buy/sell ads, taken 8 down and made edits to 3 ads. There are currently 59 posts on the buy and sell page.

Emily updated and reloaded the current ATA shoot schedule to reflect recent changes.

The President's message is over 3 years old. An updated one is requested.

In the last month, the number of members of the OPTA Facebook group page has risen from 647 to 672, up 25 new members. There are 13 requests to join waiting until they respond to Emily's screening message. The automation for the process of asking the screening question has made things more efficient. The FB page was created January 2014.

➤ 2.3 – Ontario Council of Shooters – Emily attended the Ontario Council of Shooters AGM on May 11, at 1 pm at Toronto International Trap & Skeet. The meeting was 3 hours in duration, with 10 agenda items (see agenda below). Neither of our Ministry sports consultants attended the meeting, although there was some prior indication that at least one would attend.

The following are key points:

➤ Update on the Coach clinics held May and June 2018. There were 14 participants in total, only 2 for shotgun. Discussion around timing of these clinics, the communication about the clinics, and the short notice. Master facilitators have completed their certification, and clinics should be more accessible. There was an application and cheque received for \$3000 from the Coaches Association of Ontario (http://www.coachesontario.ca/)

Unspent money from the coach clinics has been returned to member organizations.

- ➤ ONTarget is in arrears with providing its financial statements, while they wait for guidance from the Ministry. It was suggested that this non-compliance could affect all other member organizations and ONTarget was urged to attend to this as soon as possible.
- The OCS is looking for a Treasurer. A new set of job descriptions was shared for discussion. Jennie will be participating in a new role, that of administrator, someone has stepped forward to be secretary, leaving the treasurer duties unfulfilled. The secretary will be asked if they would take on the combined role. Chair: Ed Martin
 - Vice-chair: Shari Akow, who also acts as the Liaison between the OCS and the SFC.
- The second base funding installment was due in January, nothing yet. These delays may have resulted from the many changes due to the new government.
- The funding model was discussed, brought forward from a prior meeting. Recently, the base funding has been divided equally amongst the member groups of the OCS, a change from prior years where the funding was uneven, and without a clear algorithm. Of concern is that the number of members varies with some groups, including the OPTA having a greater number of members, therefore a greater financial contribution to the OCS. At this time, it was deemed easier to equally distribute the base funding but an environmental scan of other similar Provincial Sporting Organizations was suggested.
- > The Ministry continues to urge the OCS to have the member groups align their fiscal years, preferably to that of the Ministry, March 31. It was decided that when the Ministry could better articulate this, the discussion would be resurrected.
- SFC update:
 - Shari reported that there were more High Performance athletes this year, and more quota spots for the Olympics. The PanAm games are in Lima in July where spots are up for grabs for Canadians.
 - There are an expanded number of officials across Canada, with an audit of current officials
 - Massive change in governance at ISSF, under considerable controversy. The head office for ISSF will
 remain in Munich for now. Looking to increase participation of women. Susan Nattrass ran for ISSF office
 but fell short.
 - The SFC holds an executive meeting once a month, with the full board meetings once a quarter.
- ➤ Other business included a discussion around special funding from the Ministry. While St Thomas Gun Club (via the OPTA/OCS) was not successful with their grant application for \$25,000, OOTA was successful in their application for \$20,000. Further, OOTA was provided feedback on their application and was then allowed to resubmit an edited application. As far as Emily knows, St Thomas Gun Club was not offered either feedback or the opportunity to resubmit. It was suggested that each share their applications to determine key points that were provided and to create a template that would make future applications both easier, and perhaps, more successful. There is ongoing frustration concerning funding opportunities and how they are communicated by the Ministry.
- More other business was a discussion about the fact that the Ontario Council of Shooters has been notably absent in the discussion about Bill C71 and any proposed firearm bans. It was decided to share the talking points created by the SFC and to appoint a public relations/communications person who would speak to media on behalf of the OCS.
 - 2.4 Long Term Strategic Plan Pam stated she has still not revised the plan since the meeting at Galt March 30th. She promised to have it revised and out to the Board before the end of this week.
 - $2.5-100^{th}$ Provincial Championship Lori provided an update regarding the lottery license. She has been going back and forth a great deal trying to ensure all required information and documents are provided. Getting the eligibility is the first step in retaining the raffle license and this is a one-time requirement. She feels we should have the approval within the next few weeks, in time for the

Canadian Championships in St Thomas. With this process taking so long and time running out it was discussed amongst the Board members if we should just try to sell tickets for the donated gun only as this has no cost and whatever tickets are sold is all profit. The Board unanimously agreed not to purchase the ATV this year and only sell tickets for the gun.

Hamilton Gun Club has almost complete the renovations to the washrooms/showers for the campers. The kitchen is up and going. Lew Hummason has donated the portable washrooms on a trailer again this year for the west side.

The participant hats are in and have been paid for. Dominic wondered if we should order a few more to have on sale. After discussion the Board agreed and approved the purchase of 50 more hats. Dominic will contact Todd Millard to place the order.

Trophies have all been ordered and are starting to come in. Dominic stated that he will be working on getting the correct sizes for the All Star Team jerseys this weekend at St Thomas.

Emily is still working on contact information for all the past Provincial event winners and award winners to come to the Provincial championship, for a group photo, and for the banquet dinner, adding a few email addresses every day. She has confirmed with quite a few past winners who no longer shoot they are excited to attend.

Pam will email Rob Marchand again regarding the catering of the meal and advise the Board.

Lori stated that the lottery license was set up to support youth. Lori will confirm the age of "youth" with the Lottery License. All agreed to support the sub-junior and junior membership dues.

Emily stated that possible a scholarship program and the current University program would be suggestions.

Bert asked the Board to think about different programs the Lottery money could be used to support the youth in Ontario. A list will be generated at the next Board meeting in September. A raffle could be held every year to continue to generate funds to support these programs.

Paulo stated that we were late in getting this year's raffle started and we should begin much earlier in order to maximize the ticket sales. This will also be added to the September Board meeting.

Bert stated that the Hamilton Gun Club grounds were in tremendous shape, the restaurant staff and food were great and Sabina and office staff were fantastic.

Bert thanked the Board members for all the hard work leading up to and including the running of this year's championships.

Paulo stated that with the shoot offs running so late that in future better lighting needs to be in place. The east side had lights but they take half hour to come on. This needs to be address for future championships.

All agreed the shoot needed to be run more efficiently between events. In the singles championships the fields were empty before they started the 2nd 100, slow squads holding up the calling of shoot offs, loading trap houses between squads instead of between 25's, etc. The Board members were asked to develop a list of suggestions to help future shoots more efficiently and bring to the September meeting.

The Annual General meeting needs to be no more than 1 hour in length as technically this is the time it would take to change from doubles targets to singles. There is a rule in the ATA regulations around the starting time of Annual General Meeting during a Provincial/State Championship.

Announcements were being made during the program. This needs to be reminded to host clubs to keep to announcements before shooting starts.

BJ brought forward that there was a chair shooting this year but we did not have a trophy to offer. He suggested we have something in the future. Bert stated that all our trophies are engraved and this year we had 10 trophies not given out because of no entries. He suggested that perhaps the future trophies could have a plate that could be added to a trophy and if the trophy was not used it could be re-used for future championships.

Bert and Pam noticed that the 2 shooter team requirements are not clear in the program. This will need to be changed in future programs to read no more than 190% in current or past year (whichever average is higher). Also the trophy list needs better clarification. Some shooters are still reading that Champion and runner-up in each class and category are awarded trophies.

Jamie stated that the empty squads each morning was a hold up to shooters. After pre-squad closes perhaps some shooters can be adjusted to fill squads instead of having so many short squads. Posting a list of the squads like at the Canadian Championships would also help, as shooters could see the empty squads and determine when they would be on the ready.

Emily asked who was responsible for the Trophy List. Pam stated she was responsible and will get them done when she can. Once they are done Pam will send to the Board and Emily to post on the Website.

Emily asked if a survey was needed as she has done in the past. The Board discussed this and determined the comments on the surveys were unnecessary as they only seem to generate negativity. A vote amongst the Board was held and the first 6 members voted no so no further votes were required. There will be no official survey this year. BJ suggested to use Facebook rather than a formal survey.

- 26. Business arising from minutes.
 - 2.1 New & Youth Shooter Program Frank Dainty and Emily has met two separate sets of individuals at the trap club who had inquired via the OPTA email address about being interested in trying trapshooting.

Emily has responded to several other email inquiries this month about 'how to become a registered trapshooter', and others seeking information about nearby clubs and lessons.

2.2 – Website/Facebook/Twitter – Since the last meeting, Emily has uploaded 27 buy/sell ads, taken 24 down and edited 4 ads to reflect changes in information or asking price. There are currently 44 posts on the buy and sell page. The majority of ads are producing good results for those who post there.

Emily has added a biography for Bill Wylie.

All of the Canadians and Provincial information is posted, as are the 2018 award winners, and most recently, three of the five winter recreational league schedules that Emily posts every year.

The last meeting the number of members of the OPTA Facebook group page has risen to 594 from 578, up 16 new members. There are 4 requests to join waiting until they respond to Emily's screening message. Emily has started a 'new shooter interviews' in June, where she interviews shooters who are new to ATA shooting. Many of these new shooter interviews have been of new junior shooters.

- 4.6 Feedback from denied grant application After asking in person once, and sending two emails, Emily received feedback on the unsuccessful application she completed for the Canadian Association for the Advancement of Women and Sport and Physical Activity (CAAWS), Women in Sport Encouragement (WISE) Fund grant.

The following was the feedback received by email:

Let me preface this by saying that we had a record number of applications last year and there were many deserving applicants that we were simply unable to fund. Overall, your intended

impact was very clear and we can certainly appreciate and applaud your desire to expand participation of girls and women in trapshooting. That being said, your application did not provide enough specific details of your desired initiative to move it forward in the granting process:

- How many days would be offered in the series?
- How many girls/women are you targeting in total?
- Although we understand your sport is suitable to engage beginners of all ages how would this age range be organized and reflected in the introductory sessions?
- Who would train these athletes?
- Would you be targeting any further underrepresented groups?

Including those types of specific details really help to strengthen the applications so our Selection Committee has a clear picture of what the initiative will look like and how it will work to retain girls in sport and/or develop leadership skills.

While this feedback is valuable in general, it should be noted that those applications who received funding, were all supported by their National Sporting Organization, which for us would be the Shooting Federation of Canada.  - 2.1 New & Youth Shooter Program As the weather is not conducive to hosting new shooter events, those will pick up again in the spring. Emily has been getting email reminders to book a booth at the upcoming Toronto Sportsmen's Show.
 - 2.2 Website/Facebook/Twitter Since the last meeting, Emily has uploaded 25 buy/sell ads, taken 11 down and edited 4 ads to reflect changes in information or asking price. There are currently 53 posts on the buy and sell page. The majority of ads are producing good results for those who post there. Emily checks in with each seller when she take ads down to determine if their item was sold as a result of the buyer seeing it on the OPTA site.

Since the last report, the number of members of the OPTA Facebook group page has risen from 578 to 610, up 32 new members. There are 2 requests to join waiting until they respond to Emily's screening message. Emily regularly posts reminders for the winter league shoots and shoot results, when available. She also posts updates on the concerns around firearm legislation, and the media reports around it, as it is relevant to all firearm owners.

- 2.3 Ontario Council of Shooters The next allocation of grant funding from the Ministry is being held until the OCS sports consultant has the required documentation, confirmation of Schedule "D", requested in an email earlier this month. To date the OSSA and ONtarget are the only two member organizations in compliance. Pam stated she had sent in all documents that she thought were needed but will email Jennie to see what else is required by the OPTA.

The majority of ads are producing good results for those who post there.
